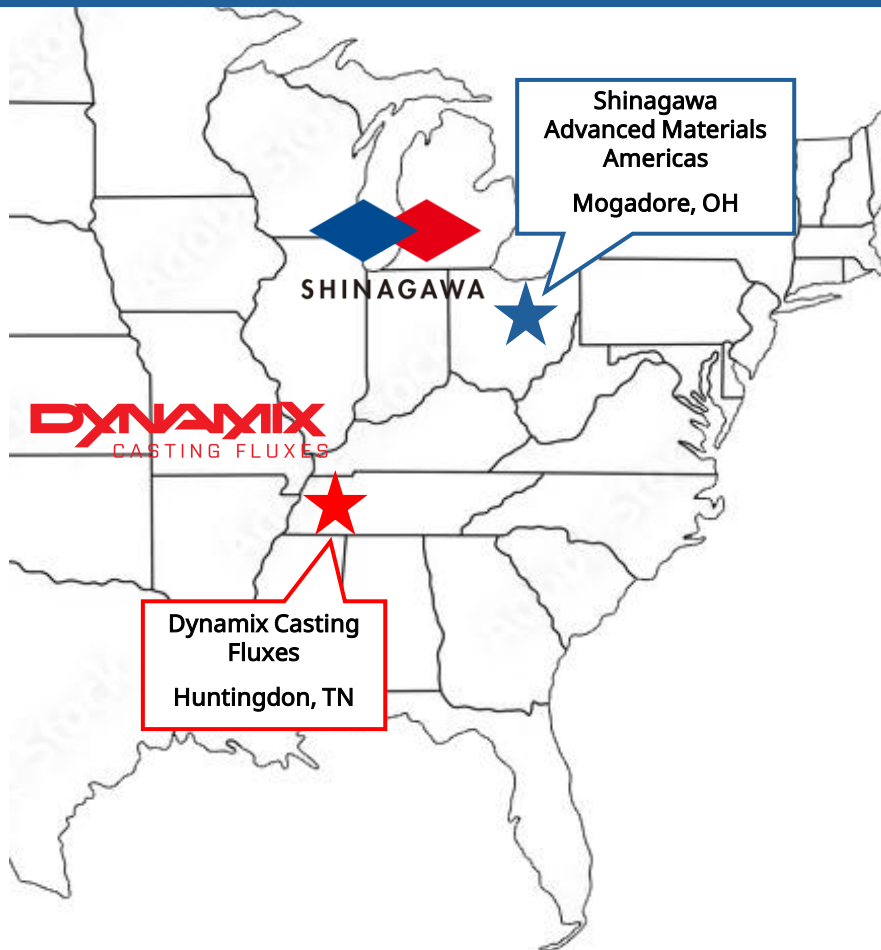


SHINAGAWA REFRA

- SHINAGAWA REFRA to acquire a 51% ownership interest in Dynamix Casting Fluxes, a U.S.-based manufacturer and supplier of high-quality mold flux products for the steel continuous casting process.
- The acquisition will be executed through a newly established U.S. subsidiary.
- The transaction is scheduled to be completed by March 2026, subject to the completion of required internal and external approvals and procedures.



Establishing a second mold flux production site in the U.S. to strengthen SHINAGAWA's core product offering for the steel industry.
